**RESOLUTION REGARDING EXTRA-TERRITORIAL ZONE  
APPLICATION FEES BEFORE  
THE EXTRA-TERRITORIAL ZONING AUTHORITY AND  
THE EXTRA-TERRITORIAL ZONING COMMISSION**

**WHEREAS**, the Amended Joint City/County Extra-territorial Zoning and Subdivision Agreement ("JPA") was entered into between the City of Las Cruces and Doña Ana County on February 3, 1997; and,

**WHEREAS**, Section VIII, Organization and Meetings, of the JPA, states "The Authority shall establish their own rules of order and procedure by resolution as they may find necessary and proper to carry out their work" and,

**WHEREAS**, the proposed fees are based on an analysis of the cost for overhead such as staff time, resources used, as well as a comparison with comparable cities and counties in the Southwest; and

**WHEREAS**, the ETZ Ad Hoc Committee and the ETZ Commission recommend the proposed new fee schedule be adopted by the ETA by this Resolution.

**NOW, THEREFORE, IT IS HEREBY RESOLVED** by the Extra-territorial Zoning Authority that the following fees (See Exhibit "A") shall apply to all applications in the Extra-Territorial Zone for cases to be decided administratively as well as those that go before the Extra-Territorial Zoning Authority and the Extra-territorial Zoning Commission, and are effective upon recordation.

**1. FEES**

- B. Postage fees shall be billed within five working days from receipt of completed applications. Applicant shall pay the full amount within ten (10) days of notification of postage cost, or the application shall be deemed incomplete and shall not be processed.
