# NM State Legislature Passes HB6 - Waives certain penalty and interest

Legislation allows for the waiver of fees under the following conditions:

- · Applies only to the second half of the 2019 taxes.
- · Accounts must be in good standing prior to May 2019.
- Payment for the tax balance must be made in full before May 10, 2021.

## New Online Payment website and automated voice response system:

The Treasurer's office introduced a new payment website that provides more convenience and better tracking of tax payments including an automated voice payment system to help lower phone wait times.


