Dona Ana County Fire & Emergency Services Fire Training Academy Schedules

Due to the training needs for firefighters and first half of the year parking lot construction. The following firefighter academes scheduled.

Firefighter Academy 23 Start Date is Aug. 31 to Oct. 7 (2019) the academy will run each Saturdays 0800 to 1700 with an hour lunch. Including Monday & Wednesdays each week times will be 1830 to 2200. Scheduled training hours is 86 hours.

Firefighter Academy 24 Start Date is Sept. 1 to Oct. 8 (2019) the academy will run Sunday 0800 to 1700 with an hour lunch. Including Tuesday & Thursday each week times will be 1830 to 2200. Scheduled training hours is 86 hours.

Firefighter Academy 25 Start Date is Oct. 12 to Nov. 16 (2019) the academy will run Saturday and Sundays both days from 0800 to 1700 with an hour lunch. Scheduled training hours is 86 hours.

Due to resource issues and instruction, each academy will be at max enrollment with 16 firefighter cadets. Placement in the course is as applications receive. Deadlines applications for FFA 23 & 24 is August 23, deadline for FFA 25 is Oct. 4. For Dona Ana County Fire Staff only: must complete active status including background prior to starting a fire academy.

Location: 1430 Portland Dr. Las Cruces NM, Training Facility

Book: Fundamentals of Fire Fighter Skills 3rd Edition, fire fighter books and skill books issued by training section.

Bring your bunker gear: coat, pants, boots, suspenders, hood, helmet, gloves & SCBA mask every day. A fire fighter is not functional without their gear. Check with your station officer to ensure all your PPE meets current safety standards. Fire fighters will need structure gloves and work gloves. SCBA packs provide by training section.
