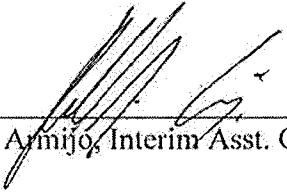

On 9/1/17 staff was called out due to backup/plugged wastewater line on Berino Rd. In the process of unplugging the line the manhole collapsed. Several vendors have been called to assist with the issue. As of today the following vendors are Southwest Envirotech, De La O Pumping, Johnny Septic, CRC, Rain for Rent, City of Las Cruces, Triple J Construction, and Smith and Aguirre Construction. Additional vendors may be contacted based on need.

Staff with the assistance of Bridel Facility Operations have contacted EPA regarding the spill and have taken the necessary steps in addressing the issue.
